VIII. MATTERS FROM THE EXECUTIVE DIRECTOR

Mr. Kippenbrock stated that he had sent out an email to the Board members regarding the fire at the landfill caused by compost operations. The temperature in one of the piles got up in the region of 180 + degrees and that caused spontaneous combustion. The high winds carried embers and it started spot fires. We got them out the first time, but on Sunday and during the week we had to knock it down further. We rearranged the piles to get a different wind flow and that seemed to work. This is not uncommon. He wants to thank everyone including BLM, the Forest Service, the Santa Fe Fire Department and our employees who helped put out the fire.

Mr. Kippenbrock said Danita Boettner is not here today to give her updates. She is on vacation with her family.

Mr. Kippenbrock said Emily Pisula had her second meeting with Mr. Bejarano, who is with City Finance, on making our audit timeline. This will be a continual meeting. We are making progress.

Mr Kippenbrock continued saying that the COVID variant is real. It has hit our agency as well. The CDC recommends that employees stay home from work for five

days and we are following that recommendation. Our employees are experiencing the common systems including congestion, coughing and a slight fever. The length of the sickness is much shorter than before.

Mr. Kippenbrock said there will be no meeting in July, but we will meet in August. We are able to take care of all we need at this time during this meeting. Out next meeting will include our roof project on the transfer station. We have identified three companies to bid. These companies have already been vetted by CCS, but we feel we need to go through the process and look at each one. The cost will be between \$200,000 and \$300,000, We want to change out the skylights to make them more clear and natural light rather than the smoky colored skylights we have now. That project will cost \$80,000.

Chair Hansen said she was glad to hear that you are moving forward with the Finance Department, the City and Mr. Bejarano. Thank you Mr. Kippenbrock.

IX. MATTERS FROM STAFF - AGENCY, CITY, COUNTY

A. SHIRLENE SITTON, DIVISION DIRECTOR, CITY OF SANTA FE ENVIRONMENTAL SERVICES DIVISION

Ms. Sitton said we are always hiring for operators and now we are also hiring for an accounting technician. We are having a Rapid Hire event on July 30th. Our new route optimization plan is coming out in July. There will be alternate route schedules so that may help us get CDL drivers. Our Outreach Coordinator and Sustainability Coordinator have left so we are looking to fill those positions. We are working hard on the New Mexico SWANA Chapter Annual Meeting. Randall is on the Board as well. A representative from Waste Connections will be there and we are hoping to be able to find some options to improve our systems.

Chair Hansen said we are all looking to hire. There is a shortage of employees everywhere. Thank you for the update.

B. LES FRANCISCO, SOLID WASTE SUPERINTENDENT, SANTA FE COUNTY PUBLIC WORKS

Mr. Francisco said we are looking for help as well and are about to do a Rapid Hire event too. We have two new employees starting. We are doing all we can and what we need to do.

Mr. Kippenbrock commented that he is using Indeed to search for employees. Rosalie received 100 applications today for the lube tech position.

Commissioner Hughes said he has a lot of experience with Indeed and you get a

lot of people responding, but most are not qualified or interested. Usually you will get a few to interview.

Ms. Sitton said for our professional positions we have had our best luck with LinkedIn.

Chair Hansen thanked Mr. Francisco for his update.

C. CAITLIN WEBER, SUSTAINABILITY SPECIALIST, SANTA FE COUNTY COMMUNITY DEVELOPMENT

Ms. Weber reported that they completed all of their Earth Day events. The participants planted over two hundred plants. We received a grant to support our tire program. We presented the Countywide Emission Report. Our composting program is ongoing. We continue to provide education and community clean ups with volunteers.

Chair Hansen thanked Ms. Weber for her updates.
