#### VIII. MATTERS FROM THE EXECUTIVE DIRECTOR

#### A. FY-23 AUDIT UPDATE

Ms. Chavez said she is in contact with CRI and CLA constantly. The May 25<sup>th</sup> submittal date is still in place. CRI has made significant progress on field testing. The quality control process audit is ongoing. CRI provided her with preliminary balance and income statements. They will let us know, as soon as we provide the draft financials, when they will schedule an exit audit.

Commissioner Greene asked if Board members typically attend the exit conference.

Ms. Chavez said the Board Chair attends.

Mr. Kippenbrock said yes, we need Board representation at the entrance and exit conferences.

Chair Bustamante said it would be helpful to have the previous Board representatives and add her.

Chair Bustamante said thank you for your good work and for keeping us on track and on time.

#### B. APRIL RESIDENTIAL FREE DAY EVENTS UPDATE

Mr. Kippenbrock said the first weekend in April was our free household waste and e-waste say. We had similar counts to last year. We also had a free tire day. The second weekend was green waste. We also have a free waste amnesty half day at both locations. Caja Del Rio had 147 customers. BuRRT has 288 customers. 57 tons of waste was collected. We will have a free trash event in July at the landfill from 7:00 am to 1:00 pm. Councilor Garcia that thank you for adding an additional site for amnesty.

#### IX. MATTERS FROM STAFF - AGENCY, CITY, COUNTY

Mr. Francisco said Santa Fe County participated in the Great American Clean Up on the 13<sup>th</sup>. We picked up 38 bags in 5 areas. All the Collection Centers gave free dumping with a valid permit. There were 149 total visits

Ms. Trujillo said three of our staff participated in the Rodeo in El Paso in the categories of front load and side load. Albert Valdez and Patricia Lopez are moving on to the National Rodeo.

#### X. MATTERS FROM THE BOARD

Commissioner Hansen shared an article from the *Reporter* about Mr. Horowitz's installation.

Commissioner Hansen said Mr. Horowitz was so grateful to Mr. Kippenbrock for all his help. Thank you.

Chair Bustamante said thank you Director Kippenbrock. You were very diplomatic.

Commissioner Greene said thank you Maria and Les for getting the days rearranged for Nambe.

Commissioner Greene asked if we have gotten any further on assessing assistance we can give Rio Arriba County.

Mr. Kippenbrock said we are still assessing the situation. He has no further information at this time.

Mr. Kippenbrock said this Saturday will be the Caja del Rio Coalition clean up. It will be from 9:20 am to 1:30 pm.

Commissioner Hansen said there will be an Earth Day at Hondo.

Chair Benavidez said La Cienega will be doing a clean-up day as well.
